

**Timber Hill Restoration Coalition  
Meeting Minutes  
May 5, 2008**

**Call to Order:** The meeting of the THRC was called to order on May 5, 2008, at 3:40 PM by Kris Roselle. The meeting was held at the Timber Hill Reservable Area in Wagon Wheel Lodge.

**Secretary-Volunteer Hours:** THRC has received 160 volunteer hours since the beginning of the year. Hours were submitted by Patti and Jacki.

**Treasurer-Financial Report, 2008 Budget:** Jackie Uhler submitted a financial report showing a balance of \$522.42 as of March 31. The updated 2008 budget was submitted having already been approved.

**MetroParks Update:** The Frisbee golf equipment will be moved to Rentschler Forest.

**Other Business:**

**Girl Scout Service Project:** Patti McDonald reported that on April 26, 2008, ten Senior Girl Scouts and 4 adults contributed 28 hours of service weeding and mulching the flower beds in front of the Administration Building and Wagon Wheel Lodge and also around the park signs. THRC collected \$58.00 for 2 adult memberships, 1 youth membership and 8 patches.

**MTV Video Shoot:** On April 30, an MTV camera crew filmed Whitney Lawson planting plants by the Timber Hill parking lot sign. She was helped by a representative of Master Gardeners and a few teen friends. Whitney is being considered for the MTV show "Made". She wants to learn a figure skating routine to be performed at a benefit for breast cancer.

**2008 Donation Levels:** The motion to accept Proposal #2 was made by Jacki Uhler and seconded by Chris Hardwick. The motion passed.

**2008 Membership Fees:** David Robertson led the discussion about the proposed membership fees. A motion to accept proposal #2 with changes as noted was made by John Lawson and seconded by Jacki Uhler. The motion passed.
